## **NB PAY FZCO Privacy Policy**

The purpose of this Privacy Policy (hereinafter referred as "**Policy**") is to inform you as to what information may be collected by NB PAY FZCO, a company registered in Dubai Silicon Oasis, DDP, Building A1, Dubai, United Arab Emirates, and with company registration number DSO-FZCO-13633, from 22-Mar-2022 (hereinafter referred as "**the Company**", "**we**", "**us**", "**our**") from you when you visit our Website <a href="http://nbp.ae/">http://nbp.ae/</a> (hereinafter referred as "**the Company**", "we", "us", "our") from you when you visit our Website <a href="http://nbp.ae/">http://nbp.ae/</a> (hereinafter referred as "**this** Website") or when you use NB PAY software published on our Website, how such information will be used by us, with whom such information may be shared, your choices regarding the collection, use, and disclosure of such information, your ability to edit, update, correct, or delete such information and the security procedures that we have implemented to protect your privacy.

### Information Collection

On various occasions you may be asked for certain types of personally identifiable information, such as:

- your first and last name;
- username, password in NB PAY;
- citizenship;
- phone number;
- e-mail address;
- cryptocurrency address;
- other personal information you choose to provide;
- other personal information we obliged to obtain from you in accordance with our AML Policy.
